

## Board of Directors Meeting

Wednesday Dec. 10, 2004

The Division 10 Board met at Pete Birdsong's home. Present were John Gorman, Pete Birdsong, Mike Armstrong, Bill Robins, Tony Lucio, and Ron Kercheval. The following items were discussed:

The Board reviewed the committee chairs (as posted in the Newsletter) to determine if changes were needed. It was agreed that Pete Birdsong would maintain the data base and do mailing labels and Tony Lucio will assume the responsibility of the Company Store.

Tony Lucio agreed to create a Division 10 letterhead.

The Board agreed to have Bill Robins & John Gorman approach the mall about continuation of the layout there for another year and for permission to build and raffle the HO layout.

Update our Store/Mall information flyer to have available to hand out to the public.

Suggest assigning one person instead of two to operate Mall layout display. Mike Armstrong volunteered to continue as Schedule Coordinator for a while longer until a replacement could be found.

N scale SIG to be paid a monthly stipend to have their layout set up at Mall, allowing them to purchase any needed parts or perform maintenance during their operation.

Door Prizes: Tickets will no longer be given out to all attendee's but will be tied to Bring n' Brag as described below.

Bring n' Brag - In order to increase participation, the following changes were made to our monthly contests:

Every person who brings a contest entry or show and tell item will be given one (1) free raffle ticket and

may purchase additional tickets for \$1.00 apiece. Other attendees may purchase tickets for \$1.00 apiece.

Reduce the number of monthly categories to three: Locomotives (all types), Rolling Stock (all types), and Structures (all types). These categories will cycle every three months.

Have four scoring periods of three months each per year with points tabulated on a three month basis. After each quarterly period, certificates will be awarded for first, second, and third in modeling and photography. After each quarter, scoring will start over with a clean slate.


At the end of the year, the Board will name the person who has shown the most ?? participation and a plaque will be awarded.

Pete Birdsong, David Greer and John Gorman will pursue having occasional AP judging events at meetings.

The idea of having round robin discussions of various modeling techniques at monthly meetings.

Estate sales: Recommended that commission charged for selling estate items be increased to either 30-35% due to amount of labor involved. Also, the idea of offering tax write-offs in exchange for donation of estate items in lieu of a sale with commission charged.

## *Modeling Tips - A Different Approach*

*by John Deville*

### Part 1: Rationale about Modeling Tips and Sources of Materials

For many years one cannot help to envy those with "sharp eyes" and have the knack of making details for locomotives, rolling stock, scenery, and structures of various types. After close observations and the taking of notes of many layouts as well as the real world that one lives in, these observation notes give the opportunity for a model rail-roader or a model builder to decide what he/she wants on a layout to have a more nearly accurate view of reality.

The second factor of the rationale is the search for the raw, available materials in the present environment that one can easily find and use to build the needed items, especially when it can be

free and/or won't cost "an arm and a leg."

### Part 2: Sources of Building Materials

A. One of the chief standbys can still be the lumber...wood that can be easily scrounged from trash cans of home improvement centers (I tried this; just ask the right employee...he/she will love you to death!), cabinet and furniture making shops, picture frame stores and lawn mower repair and sales stores. Smaller pieces of wood can be obtained from fast food restaurants and convenient stores (coffee stirrers). Eating at Asian food restaurants can yield chop sticks. Wooden crates have longer lengths to forage from furniture stores by asking the manager for them. I am sure that many of you can name many places to get strip wood and wood sheets.

B. Another common material all around us is plastic. The right type that can suit your needs and easy to cut, saw and carve has to be experi-

mented with.

Examples of plastic you can try to use are: computer shells (of monitors, hard drivers, printers, computer ribbon cases, etc.) for the thick flat/curved sheets, plastic coffee stirrers, plastic knives and spoons (handles in this case), plastic trays of common TV dinners, plastic sheets as a subsurface for patio bricks, plastic bands on bundles of magazines and newspapers, and even the bottom of yogurt containers.

C. Don't forget metals as found in food cans, air condition filters, pieces of metal gutters, and even, of all things, aluminum wraps.

Now we reach the end of this inspirational fun, if you like the article, tell your Division 10 editor. I can have more articles on "modeling tips" in future issues of theLantern. Next time we can deal with the mechanics of utilizing the raw materials.
